The Executive Committee shall consist of:

Chairperson/ President Principal

Vice Chairman/ Vice President One among the parents

Secretary One among the teachers

Jt. Secretary (2) South amongst parents

Member One parent and one teacher from

every Standard

There will be 50% female representation in the Executive Committee.

On the Executive Committee, at least one member belonging to the Scheduled Castes, Scheduled Tribes, or Backward Class of Citizens shall be appointed by rotation so that every category gets representation, every year.

A list of Executive Committee members will be published/displayed on the notice board and school website.

The Executive Committee members will have a meeting at least once in three months.

Notice of the meeting will be given in advance to all the Executive members either through Registered post or through any electronic mode of communication.

The procedure for conducting a meeting of the Executive Committee will be strictly under the provisions of the Maharashtra Fee Regulation Act, 2016.

Other than the duties of the executive committee no other personal agenda/complaints will be entertained during the Executive Committee meeting.
